# Faith Lutheran Church Council Meeting Minutes March 18, 2019

Meeting called to order: 7 p.m.

**Review of the Minutes** – Not available. Will review at April meeting.

### **Staff Reports**

Treasurer: none submitted.

- Pastor Jean Hansen report attached. Noted that March 20 is next Interfaith Justice Series service and discussion at Temple Israel. All encouraged to attend.
- Pastor Rick Gordon report attached. He noted his conversation with a member about welcoming people from the LGBT community to attend worship. He mentioned to them our Reconciling in Christ efforts. They were relieved.
- Bob Manning. the Outreach Ministry continues to gain momentum, enthusiasm and support from the congregation. During the month of February, 33 volunteers served at Holy Trinity; our congregation and preschool families donated many needed items for the DLM Food and Resource Ministry. In March we are collecting items for Lutheran World Relief; Marilyn Wilson gave a Temple Talk update on the Thailand Mission that we support; our Interfaith Justice Series (IFJ) continues and we are serving lunch to the community at OPEN M with our IFJ partners. The month ends with Faith members serving at the DLM Food Bank at Holy Trinity. Bob will present an outreach update to the congregation on April 7.

Bob completed a study of where our monetary donations for outreach have been going the last three years. He found that most of our donated funds go to support OASIS and the Thailand Mission trip, after the mission support (benevolence) contribution to the NE Ohio Synod.

Faith has not budgeted for outreach for a long time and we need to decide how we fund outreach efforts going forward. In 2019, the new outreach effort was supported by a grant from the SJ/SP Endowment.

President's Report - nothing discussed.

#### **Old Business**

Bequest from the estate of George F. Eckert: no new information to discuss.

- Triad update. The Communications Team is meeting March 28, to review two options for the new website. The communication plan that was drafted is also being reviewed. Rollout of the new website could be within the next 60-90 days.
- RIC Core Team formation update Tom Antal, Karl Demuth, Joe Gardner, Kit Scheetz, Sandy Selby, Linda Weigand and Marilyn Wilson were asked to serve on the RIC Core Team. Pastor Jean reported that all agreed to serve except Marilyn Wilson who is unable to participate due to prior commitments but is supportive. The next step will be to meet and decide a chair for the team. Pastor Jean mapped out a timeline for the team.
- Greeters-Between-the-Services update Pastor Jean reported that we have 10 people
  willing to serve as greeters and will they will begin in April. Each Sunday from 10:15 to
  11 a.m. there will be a greeter in the Welcome Center, with a nametag, to welcome
  people, especially newcomers, assist people to find their way and introduce them to
  others.

Pastor Jean updated all on the state of the current website. It had been inactive for a couple of weeks. Gabe updated the site so that it could be used, however the update knocked out the ability to send the prayer list and weekly e-news through the website. Pastor Jean is sending out the prayers and weekly updates through Outlook.

#### **New Business**

Operating Account Analysis – John Weisend

John reviewed several budget structural changes that have taken place. "Building and Grounds" has moved to the Operating budget. The SJ/SP Endowment Grant for Outreach, received in 2018, is being used toward Outreach Ministry in 2019. That money was put into prepay, a new way of doing it, so that it matches revenues to expenses. John proposes a third change, and that is to record payment of (unbudgeted) expenses, that have been approved by Council, in the appropriate budget line. We've been in the habit of transferring such payments directly from savings and the expense loses visibility, making it difficult to track how money was being spent.

We need to keep our revenue in mind for future planning. It is estimated to be down about 2% next year. Pastor Jean sees challenges ahead in the congregation. The number of long-time, active members is declining due to moves, deaths and decisions to attend worship elsewhere; this affects income. New members are joining but are not as active in terms of worship attendance or making contributions as those long-time members. This is a trend that will most likely continue.

We need to be proactive; one of the ways of doing so is with our outreach program and our website redesign/communications plan. These are ways to interest people in our Faith community.

Having money available for (new) staffing in 2020 comes down to revenue, John W. noted. The mortgage is paid off, we have money in the bank and assuming no major building expenses, we just need to be cautious. Pastor Jean noted that calling a pastor or deacon is unlikely due to the cost of the benefits. She said our priority is keeping the

outreach ministry going; it's important to fund that position. At the next Council meeting we will discuss forming a Task Force on staffing.

Adam Ashenfelter proposed that we accept the accounting change to record payment of non-budgeted expenses in the appropriate budget line/area. Dana seconded. All were in favor. Motion passed.

 Council members are needed to strip the altar. A sign-up sheet was passed around.
