Church Council Meeting September 18, 2023 Minutes Faith Lutheran Church

Call to order: The meeting was called to order at 7:06 p.m. by Loralee Daily, president.

Review of the Minutes

John motioned to accept the August 21 minutes; Dana seconded the motion. All were in favor. Motion passed. Dana motioned to accept the August 31, Executive Committee minutes; Karen seconded the motion. All were in favor. Motion passed.

Staff Reports

Treasurer

August had a significant deficit (\$23,447) due to this being a traditionally lighter giving month. Also, there were higher than normal expenses, including an unexpected expense of the office door repairs, due to the church break-ins. With the sizable expenses in a low revenue month, our annualized deficit grew to \$26,319. We don't foresee the large expenses to continue and based on past years, we expect our giving to increase through the end of the year. John motioned to accept the treasurer's report for review; Dana seconded the motion. All were in favor. Motion passed.

Old Business

Proposal for increased security – hire security consultant?
 Due to Council not reaching a decision concerning increasing security at last month's meeting, John Reyes reached out to Tim Dimoff, principal in the company SACS Consulting & Investigative Services, Inc. to inquire about providing a security needs assessment, with the knowledge up front that we may not hire him. He agreed and requested a fee of \$1,500 (discounted from \$2,500). John will donate \$750 towards that cost.

Pastor Jean contacted four area churches to inquire about their security measures and reported on those that had responded.

Tom motioned to hire Tim Dimoff to provide a security assessment, John seconded motion. Seven were in favor; one person was not in favor. Motion passed.

- Potential Sanctuary, Fellowship Hall roof projects Loralee Daily, John Reyes
 Beth Iacano, who is knowledgeable about building/construction matters, agreed to be
 the point person for the roof project; Brian Vincent, who is not a Faith member, but is a
 contractor, and is the husband of Faith member Nicole Vincent, agreed to work with
 Beth and share ideas and provide guidance as needed. They are contacting three roofing
 companies that work with tile; Beth with meet and talk with them.
- Preschool LLC Status Update John Reyes
 John submitted a report which details the reviews and supports the proposal for Faith
 Preschool to operate as an LLC. These details were presented to the Preschool "Board"
 who supported the move to create an LLC. Karen motioned that we accept the
 proposal, dated March 24, 2022, to operate Faith Lutheran Preschool as an Ohio LLC and
 move forward with the engagement of attorneys Rich Fry and Nate Fulmer; Tom
 seconded the motion, John Reyes abstained, all others voted in favor.
- Sexual Abuse Response Team
 The team needs established and, according to Faith's "Keeping Kids Safe" document should consist of the pastor, council president and two congregation members. The two people to be asked are Wendy Gajarsky and David Nevergall. Dana will call them. If they are not interested, then she will contact Lori Ashenfelter and Linda Weigand. A decision can be made at the next council meeting. Following the creation of the team, they will meet once a year to review policies and procedures.

New Business

Budget process for 2024 – John Weisend
John presented the preliminary 2024 budget with highlights of changes from 2023
budget. There will be COL increase of 4% of all salaries.

Additional Changes: The Lenten Program is currently a line item under Shared Worship Expenses and should be moved to Outreach and titled Interfaith Justice Series. The Mission Trip has never been in the budget due to always being funded with a Faith Endowment grant and donations. John would like to see it in the budget, as well as other similarly funded outreach projects, and will consider how to add them, possibly with revenue source noted. The Communications line item increased to \$2,150.

John is looking at CDs to take advantage of the higher interest rates on cash that is sitting in savings.

One area of potential savings worth investigation is whether the Preschool becoming an LLC would mean that Preschool employees are not counted as FLC employees, so that there would be less than 20 FLC employees, thus making it possible for Pastor Jean to make Medicare her primary health insurance, saving the church approximately \$10,000.

 Nancy Tobar will be taking time off Nov. 10 – 19 for surgery/recovery; possibly returning on Nov. 20 Someone is needed to take notes at the Annual Meeting on Nov. 19.
 Dana will ask Em Antal to take the minutes.
