## **Old Business**

# Service Master Re-Build Contract

The contract was reviewed by attorney John Reyes; it was very complicated and suggested changes were forwarded to Service Master. We are waiting for a response from Service Master's attorneys. Loralee will follow up with John Reyes for his input concerning signing the original contract without the changes. Pastor Jean made a motion to, with affirmative input from John, sign the original service master contract and to begin the work. Tom seconded the motion. All were in favor. Motion passed.

### Special Assistance Fund Protocol Draft

The Special Assistance Fund Protocol Draft created by Nicole Vincent and Pastor Jean was considered unacceptable when reviewed by attorney Nate Fulmer. The Council decided not to pursue hiring an attorney to create a protocol for the Special Assistance Fund. Loralee will

follow up with John Weisend concerning this decision. It also was decided that until the Finance Committee determines what it wishes to recommend to the Council, decisions concerning using the fund will be made by the Pastor, as has previously been the case.

## **New Business**

Report and Recommendations from the Security Team

Reports submitted. There are 4 quotes for an updated security system that were gathered and presented by Andrew Fligor. Judy emphasized that the updated security system will not impact the daytime functioning of the building. The Team gave recommendations including proceeding with the quote from Vector Security, doing at least Phase 1. A comparison of costs was reviewed by Keen. Initial costs for the Door Access and Security System were reviewed; the current camera system is outdated but will continue to be used. Loralee motioned to hire Vector for an initial Cost of \$26,800, including the locksmith cost of \$3,275 and a monthly monitoring fee of \$78; Tom seconded the motion. All were in favor. Motion passed.

The Security Team was asked about the decision to keep the doors on Market Street locked on Sunday. The reason for doing so is that the foyer, and much of the building, is unoccupied, especially during 9 a.m. worship. It was suggested that adding a greeter or usher to the Foyer, as well as doing some training of the ushers, would be an alternative to locking the doors. Having an usher in the Foyer during 9 a.m. worship will be discussed with 9 a.m. Usher Team Leader John Knops.
